REGISTRATION & FEE PAYMENT

Before July 10th, 50% of fee payment is due with mail-in registration to secure a place in classes. Class sizes are limited to allow access to the aerial equipment, so register early. Full fee payment is due by July 10 and registrations thereafter require full payment. Failure to complete payment will result in forfeiture of a secured place in classes. Check or money orders only, made payable to Frequent Flyers Productions. Foreign students MUST send money orders in U.S. dollars. We do not accept credit cards.

Students must register for the full class session as material is contiguous. No drop-ins.

A one-time \$20.00 registration fee is required for each student to cover administrative overhead. (Enrolled CU students are exempt).

REFUND POLICY

The \$20 registration fee is non-refundable. Refunds will not be issued until after the ADF 2009, no exceptions. 100% of the payment (minus the \$20 registration fee) is refundable through June 12th. From June 13th through July 10th, 90% of the payment is refundable. From July 11th through July 24th, 80% of the payment is refundable. After July 24th there will be NO REFUNDS.

LIABILITY WAIVER

PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

In consideration of the services of Frequent Flyers Productions, Inc., their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "FFP"), I hereby agree to release, indemnify, and discharge FFP, on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that my participation in a low flying trapeze and aerial dance class entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: Aerial Dance activities entails certain risks that simply cannot be eliminated without jeopardizing the essential qualities of the activity. Without a certain degree of risk, Aerial Dance students would not improve their skills, and the enjoyment of the activities would be diminished. Aerial Dance activities expose its participants to the usual risk of cuts and bruises. Other more serious risks exist as well. Participants can fall off equipment, sprain or break wrists and ankles, and can suffer more serious injuries as well. Traveling to and from shows raises the possibility of any manner of transportation accidents. In any event, if you or your child is injured, your or your child may require medical assistance, at your own expense.

Furthermore, FFP employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless FFP from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of FFP's equipment or facilities, **including any such claims which allege negligent acts or omissions of FFP.**
4. Should FFP or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
6. In the event that I file a lawsuit against FFP, I agree to do so solely in the state of Colorado, and I further agree that the substantive law of Colorado shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against FFP on the basis of any claim from which I have released them herein.

I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
